## PRESIDENT'S ADDRESS




It is with great pleasure I give my Annual Report to Fellows for the year 2007. The year has been an exciting and challenging one for the College. Despite the climate generated by the uncertainty of contract changes, the passing by the Oireachtas of a new Medical Practitioners Act and the formation by the HSE of a Medical Education Training and Research Committee the College maintains its focus on its core objectives of education and training for Anaesthetists and the maintenance of standards of anaesthesia in Ireland. For this I thank all Council Officers and Council Members, Fellows and College staff who continue to work so hard to support the College to achieve its objectives.

In my report for 2007 I referred to our ambitions for 22 Merrion Square. I am delighted to confirm that planning approval has been granted to develop the site as a modern education and training facility that reflects the new demands and expectations of the 21st century. The College has taken over 22 Merrion Square and in 2008 expect to begin building a new educational facility at the back of the premises with additional facilities in Denzille Lane. We look to our Fellows and all anaesthetists to support this project.

#### **EDUCATION & TRAINING**

This is the core business of the College. In 2007, we have revamped the MSc. and added to the number and variety of modules thus widening the appeal and relevance of our MSc. programme. In the new climate of CME and CPD as reflected in the Medical Practitioners Act 2007, we feel this is an additional resource for our Fellows to develop and maintain their professional practice. Our website www.anaesthesia.ie enables Fellows to maintain their CME record on-line and the additional feature of access to journals both on-line and in hard copy is an expansion of our service to Fellows in 2008 and beyond.





The Autumn College Lecture was delivered by Prof Pierre Coriat in conjunction with the Core Topics day in Belfast and our Winter College Lecturer was Dr Beverly Orser. Our Gilmartin Lecture was delivered by Prof Garret Fitzgerald. All were outstanding choices and contributed considerably to the educational meetings held in association with the lectures. My thanks to Dr Joe Tracey and to those who put so much time and effort into the educational meetings.



#### **EXAMINATIONS**

The examinations continue to develop and evolve. A special thanks to the Chair of our Exams Committee Dr Ellen O'Sullivan for managing these changes. We also thank Dr Harry Frizelle and Dr Julian Johnston, Chairs of the Primary and Final FCA Exams respectively who have been pro-active in achieving change. Thanks also to our examiners who contribute so much. It is with regret that Dr Johnston, due to work commitments, has relinquished the Chair of the Final FCA Exam but we welcome and congratulate Dr Kevin Carson as the new Chair of our Final FCA Exam.

#### **DEAN'S OFFICE**

Our Dean Dr lan Surgeon has been, and continues to be, a stalwart in the College since its inception. His vision, attention to detail and communication skills have been a major contribution to the success of the College. 
#### **M**ANAGEMENT AND **A**DMINISTRATION

#### **PROJECTS**

## **REGISTRAR'S REPORT**


2007 was a significant year for the College of Anaesthetists as planning permission was granted to redevelop our training facilities at 22 Merrion Square North. The staff and I are delighted with the planned renovations and we look forward to offering excellent new education, training and exam facilities on site. We eagerly await the completion of the new lecture theatre within the offices which will enable us to hold many of the bigger meetings on site that have traditionally been held in venues outside the College. In addition to the renovation of the offices and meeting rooms in Merrion Square, the new Education Centre which is planned for Denzille Lane will undoubtedly provide us with many opportunities to expand the scope of our activities for the Specialty into the future.



2007 has been both active and eventful. The College Council met on six occasions, the Sub-Committees of Council met forty times. Six examinations were held for eight hundred and fifty candidates. We conducted four workshops, five courses and ran five meetings at which over one thousand people attended showing a twelve and a half percent rise in attendance on 2006. The College is actively reviewing our education and training activities and our overall educational direction. We are working with the National Awarding Bodies to ensure that we maintain our standards of excellence. Our education and training activities continue to be popular and successful both due to the diligence and industriousness of the administrative staff in the College but also due to the invaluable voluntary efforts of our fellows. The College most certainly owes its success in 2007 to the continued efforts of the College Tutors, speakers and course organisers who work tirelessly with us throughout the year. I wish to acknowledge most sincerely these invaluable efforts. I also wish to take this opportunity to thank the members of Council and its Committees on which people act in a voluntary capacity.

In 2007, the MSc in Anaesthesia was restructured and renamed MSc in Medical Professionalism (Anaesthesia) and the first intake into this new course was in September. This postgraduate programme is open to all consultant and trainee anaesthetists. It may be taken on a part-time or on a modular basis. The MSc, which is awarded by the National University of Ireland, carries with it credits which are verified within the National Framework of Qualifications. These credits are recognised nationally and internationally. It is also accredited by the College of Anaesthetists for Continuing Medical Education points.

Financially, 2007 has been another healthy year for the College. It is our aim to provide education and training to our trainees within a financially efficient framework. In our prudent financial management we endeavour to ensure that we meet this objective. Through subscriptions, donations and with the support of the Postgraduate Medical and Dental Board, in 2007 we have been able to meet the revenue requirements to sustain current College activities.





## However, it is the College's position that:

- Training in Anaesthesia, Intensive Care and Pain medicine, in common with other interventional specialties, is a high-cost process.
- Funding for training must take into account that a considerable amount of this training into the future will take place in National Skills Centres or on simulators.
- Funding for training and administrative staff, within the College and within hospitals, must increase to accommodate increasing workloads in anaesthesia, intensive care and pain training, and training of other disciplines in core or specific skills.
- Funding for ICT infrastructure and staffing must increase in line with the increasing use made of, and demands made by this sector.

Anaesthesia training is a high-cost process. Funding of training will need to increase significantly to allow training to move from the 'apprenticeship' model (as a by-product of clinical activity by consultant trainers) towards formal training activities. The allocation of funding for anaesthesia training must take into account that whilst some training can take place in the clinical setting, the risk of patient harm requires that a considerable amount of training will take place in Skills Laboratories or on simulators. These technologies will also be used for assessment and accreditation.

At the moment, training in anaesthesia, intensive care and pain medicine for the most part follows the traditional Irish model of apprenticeship training supplemented with lectures, tutorials and courses, delivered both within hospitals and also at the College and other venues. Specialist training has been modularised for some years now. Along with the College's administrative staff who oversee and regulate this process the College works with forty-two hospital-based voluntary College Tutors whose role is to co-ordinate training and educational activity within their hospital, and to act as liaison with the College.



The vast majority of training, both vocational and didactic, is however delivered by consultant anaesthetists, along with significant input from 4/5 SpRs and other disciplines such as biomedical engineers. All of this work is also voluntary although the current consultant contract does identify teaching and training as duties of every consultant. Furthermore the College does not simply provide training in anaesthesia; we also provide training in Intensive Care Medicine and Pain Medicine, and those being trained are not just anaesthesia trainees; we teach vital core generic competencies to trainees from a variety of different disciplines such as internal medicine, surgery and emergency medicine, all of whom rotate into




anaesthesia or intensive care medicine. The College has introduced a programme of Competence-Based Training throughout the seven year training process to complement the existing six-monthly in-training assessments and the mainly knowledge-based FCARCSI examinations. The College has also taken ICT initiatives to provide a virtual learning platform, a library access portal and online facilities for its tutors, and has begun to use simulators in its courses and examinations.

In the immediate future there will be changes in the way training is delivered, caused by factors such as reduced clinical exposure brought about by the European Working Time Directive, and increased medical and public expectations regarding standards of treatment and patient safety. Many of these changes are underway. The introduction of competence assessment for clinical scenarios, and proficiency assessment for clinical procedures, involves a significantly increased workload for individual tutors and trainers within hospitals, and increased time and expense in the College devoted to the development and administration of these competency systems. The use of ICT by the College to administer its training system and to provide central educational resources for dissemination to trainers and trainees around the country will increase dramatically, as will its capital and revenue costs.

In 2007 Pain Medicine was established in its own right as a Faculty of the College and we anticipate that in the near future disciplines such as rheumatology, palliative care and rehabilitation medicine will take part in pain medicine modules. We are in the process of establishing training modules in Perioperative Medicine in the Intern year and planning similar modules for SHOs of all disciplines to acquire core "hospital at night" skills and knowledge. While our main focus has to be our own specialist registrars, these skills are now very much in demand from trainees in other specialities. The College is taking a broad view of what we have to offer to multi-disciplinary training in the spirit of the Buttimer report. We are aware however, that all of these activities will incur significant costs in the future.

To improve training, and support competence assessment, the College believes that investment in the development of Skills Laboratories or Simulator Centres is essential. The pressures of reduced clinical exposure and increased standards for patient treatment and safety will likely make this type of training mandatory. Technologies are now available for training in the practical skills necessary in Anaesthesia, Intensive Care and Pain Medicine. These technologies enable rapid acquisition of skills and experience which take a long time to encounter during routine clinical workload. They are expensive to buy but are much more expensive to run because of the major input required from trainers, their need to be housed in a specialized facility, the requirement for trained technical support, and the ongoing costs of maintenance and consumables. Nevertheless this type of training has been shown to decrease adverse outcomes in patients experienced as part of a 'learning curve'.

This is the future of training in Anaesthesia and these technologies are widely used in other countries.


The College is addressing this through the development of our Education Centre at Denzille lane and is in the process of exploring the possibility of working with other Centres regionally.

Measures of outcome in the training system beyond in-training assessments, formal examinations, competence assessments and simulator-based validations of procedures and scenarios, are difficult to determine. However the College and other stakeholders are involved with HIQA in setting up a benchmarked system of audit of outcomes in Anaesthesia and Intensive Care Medicine. Such audits can be compared to international benchmarks, and serial application can perhaps throw some light on training improvements or otherwise. The College believes that the developments outlined above are consistent with the standards and recommendations set out in the report "Preparing Ireland's Doctors to meet the Health Needs of the 21st Century" (Buttimer Report).

I would like to express my extreme gratitude to the College Council and all the members of the College Committees who work tirelessly on a voluntary basis on behalf of the College. Finally I would like, in particular, to thank the Honorary Officers who have been most supportive throughout.

# POSTGRADUATE DEAN'S REPORT

As in previous years, much of the Postgraduate Dean's activity is referred to in the reports of the Training, Examination and Education Committees, and the core work of the office related to trainee rotations and assessments continues. There are however some other areas which have involved significant input and are worthy of some comment.

#### INFORMATION AND COMMUNICATION TECHNOLOGY

During 2007 it became clear that the College's IT administrative system would be unlikely to meet the College's future needs. Following a tendering process, the College appointed a company to develop new software. Work began on this system in December 2007 and is progressing in a satisfactory manner. The target for implementation of the system is May 2008.




The College website has reached a sufficiently advanced stage of development that it has become a useful resource. On foot of HSE funding support, College fellows and trainees can access full text articles in six popular anaesthesia-related journals as well as abstracts in thousands more. Fellows and trainees can record CME and training activity and points using convenient calculators. There is detailed information on the College's training and examination processes including exam results, and the regulations pertaining to both these areas. Again facilitated by HSE funding, there is access to an e-learning portal which currently contains a significant amount of material for BST training, as well as some material for the Master's Degree course and teaching material on the use of the e-learning site and supportive software. There is an active news, events and calendar section, and details and advertisements for upcoming meetings and courses, including applications. The functionality of the website should increase even further in 2008, particularly in e-learning content and integration with the College's new administration system.

## **HSE PROJECT FUNDING**

The HSE again provided project specific funding in 2007. The following projects received funding support:

- MODULAR BASIC ANAESTHESIA TRAINING PROGRAMME: This e-learning project
  received further support to complete more modules and also to provide each
  tutor with a software license and computer headset enabling the bundling of
  PowerPoint presentation slides, along with synchronised audio and video overlay,
  into a self-playing format suitable for accessing via the College e-learning platform.
- TUTORS' EDUCATION DAYS: A training session on the use of the software described in the paragraph above was held on 9th November with eighteen attendees. An information and update day on the College's procedures and changes in trainee assessment was held on 28th April, with eight attendees.





- ON-LINE JOURNALS: Funding was provided to enable another year of on-line journal subscriptions as in 2006, with the addition of a further title. Trainees and Fellows can access these journals via the College website, as mentioned above.
- SPR 4/5 POST FOR REGISTER OF MEDICAL SPECIALISTS: During 2006, the HSE had funded a Temporary SpR 4/5 post for a two-year rotation, which commenced January 2007. For 2007 the HSE agreed to fund a second such post, commencing July 2007. Both trainees appointed to these posts are currently working their way through their rotations.
- TRAINEE PORTFOLIOS: Funding to produce these portfolios was provided in 2006 and they came into use in January 2007. Their adoption appears to have been successful. They contain the training and examination regulations along with all the assessment forms a trainee will require during the seven year training process. The portfolio will thus build into a comprehensive and permanent record of training.

#### NATIONAL AUDIT OF BASIC TRAINING POSTS

This has been in progress since the summer of 2007 under the auspices of RCPI and funded by the HSE. The College of Anaesthetists is a stakeholder along with the other Training Bodies. It is a survey of all non-SpR NCHD posts in all disciplines in Ireland and is thus a very large undertaking. If it can be brought to a successful conclusion it will provide much information which is currently unavailable and which may allow a more structured approach to manpower planning and management and training requirements in the future.

## PROTECTION OF EMPLOYEES ACT 2003 AND NCHD CONTRACTS

The College has been involved, along with other stakeholders, in discussions arising out of the implications of the above act for current NCHD contracts and consequent effects on training posts and training rotations, including in relation to eligibility for contracts of indefinite duration. These discussions are ongoing but are scheduled to conclude in the first half of 2008.



#### **EXAMINERSHIPS**



We would like to wish them continued success in their future careers.

Currently there are 95 SpR training posts in Ireland – two SpRs are undertaking part time training funded by the flexible training program of the Postgraduate Medical and Dental Board. During 2007 18 new SpRs were appointed to the substantive programme. A number of SpRs are on leave at any one time and are working either abroad in clinical/ research posts but increasingly in fellowship/ research posts here in Ireland. During Years 1-3 an SpR may take time out after obtaining the final Fellowship. A maximum of one year's accredited leave is available during the entire SpR programme.



Currently eighteen months of the final 2 years SpR4/5 must be completed in clinical posts in Ireland. Progression interviews are held in the College for each SpR before entering SpR Year 4. Any modular training requirements are identified which are necessary to complete training. Again exit interviews are held near completion of SpR 5 to approve their accreditation.

Seven temporary SpR4/5s were appointed during 2007 - the Temporary SpR4/5 Scheme allows trainees to complete training and gain entry to the Register of Medical Specialists. Dr Ian Surgeon, Postgraduate Dean coordinates the national SpR rotations and continues to develop our structures to enhance training in anaesthesia.

Dr Carlos McDowell continues to coordinate the TRAS Exemption Scheme (previously Section 7.6) on behalf of the College. However this is currently under review by the Medical Council and changes are expected to this scheme in 2008.

The European Working Time Directive pilot programs are due to finish in June of this year. The anaesthesia pilot sites are complete and reports have been forwarded to the National Implementation Group (NIG). College continues to be represented on the NIG by Dr Catherine Motherway (past Chair of Training Committee) to ensure that any proposals arising out of these pilot programs are consistent with our training standards.


The NIG will produce a report before the end of 2008 on the feasibility of these EWTD pilot schemes.

The College website (www.anaesthesia.ie) has much useful information with regard to the activities of the Committees of the College. Currently 6 journals are available online to all members in good standing - "British Journal of Anaesthesia"; "BJA CEAOCP"; "Anesthesiology, Anesthesia and Analgesia"; "Anaesthesia and Intensive Care Medicine" and "Intensive Care Medicine". Also the MSc programme run by the College has a number of modules available to the candidates on the website.

The past year has been a busy one for the Education Committee with a large number of courses, workshops, lectures, competitions and the Irish Congress of Anaesthesia. The Committee met five times during the year on 7th February, 18th April, 20th June, 5th September and 21st November 2007, and reported back to the Council and the President.

#### **COLLEGE WORKSHOPS**

Again this year all of the workshops proved to be very popular and most were oversubscribed. The first one of the year was the Vascular Access Workshop run by Dr Alan McShane on 12th February and the Echocardiography Workshop run by Dr Michael Griffin was on 23rd February. A successful Paediatric Workshop was also held on 25th April. One successful Train the Trainers courses were run this year on 31st May and 1st June. A Difficult Airways Workshop was held on October 24th in the College and was organized by Dr Ellen O'Sullivan.

#### **DELANEY MEDAL PRESENTATION**

The Delaney Medal presentation took place in the Radisson Hotel on Thursday 1st March. The adjudicators were Dr Aiden Synott (Beaumont) and Dr Catherine Motherway (Limerick). Fannin sponsored the reception which was held afterwards in the Raddison Hotel. The winning presentation was Dr Brian Pickering with a presentation entitled "Anaesthetic agents differentially affect intracellular calcium homeostasis in both resting and stimulated neuronal cells".

### **AUTUMN COLLEGE LECTURE**




The Final FCA Revision Course was held 19-23rd February. This was organized by Dr Kevin Carson with a new format which proved very successful with the attendees.

## **HOSPITAL INSPECTIONS**

In 2007 in my role as Hospital Inspections Coordinator, three inspections were arranged on behalf of the College of Anaesthetists to assess and approve training in hospitals. At least eight inspections are planned in 2008. This presents quite an organisational challenge to the College and I want to once more express my gratitude to all the members of the College Council and Training Committee for assisting me in this work. The participation of either the Registrar or the Dean of the College in the inspections as well as the excellent administrative and secretarial support of College staff must also be acknowledged. Every hospital with recognised training posts is required to be inspected once every five years. An additional inspection to gain recognition for either more training posts or recognition of the suitability of the training to more advanced trainees can sometimes be accommodated but is best planned and applied for as part of the five-yearly review.

The inspection has a number of components and detailed guidance on the process and documentation required is available on the College website. It is important that any hospital seeking approval for training read these documents. This will ensure that the correct information is forwarded to the College and that the hospital uses the guidance to prepare for the visit, thus helping to make the inspection a success.


Last year we introduced a more structured data collection sheet. Meetings with the management of the hospital, the consultants and most importantly with the trainees in the department being inspected are minuted. Secretarial support from the college ensures this is done and the ensuing report and recommendations reflect as closely as possible the information collected on the day of the inspection. In this way, departments can see to it that issues they highlight are addressed in the recommendations and this support from the College is used for the development of the anaesthetic speciality in the hospital inspected. All inspections involve two consultant anaesthetists, the Postgraduate Dean or the Registrar plus a member of the College's administrative team. The report and recommendations are forwarded to the Training Committee and recommendations once agreed by the Training Committee are issued to the hospital at the earliest date. It is our intention that this will streamline the process and lead to a reduction in the time from application for inspection to issuing the recommendations.

The inspection process is one of the cornerstones of the College's role in regulation of training in Ireland and we are grateful for the cooperation of all members of the departments inspected, both consultants and trainees, in this important area of the work of the College. # CREDENTIALS COMMITTEE REPORT

#### REPORT OF CREDENTIALS COMMITTEE 2007

This is my first report as Chairperson of the Credentials Committee. I took over the Chair from Dr Rory Dwyer in June 2007.

The main work of the Credentials Committee relates to assessment of anaesthesia training and experience for the purposes of inclusion on the Register of Medical Specialist (RMS) – anaesthesia and advising on further training if required.

The Medical Council refers applications for inclusion on the RMS – Anaesthesia to the College of Anaesthetsists for advice on eligibility. Inclusion on the RMS – Anaesthesia indicates a doctor is fully trained and accredited in the Speciality of Anaesthesia. If an applicant has travelled abroad and has not completed the SpR training programme in Ireland, the Credentials Committee seeks to establish whether the training and experience of the applicant are equivalent to the standard of a holder of a Certificate of Specialist Training issued by the College of Anaesthetist. This process requires detailed documentation and confirmation of all anaesthesia training and experience achieved by the applicant. The applicant's training and experience is evaluated with reference to the Specialist Registrar Completion Assessments contained in the College of Anaesthetists Training Portfolio 2006. Following this comprehensive process the College then advises the Medical Council as to the inclusion of the applicant on the RMS. The Medical Council may accept or reject this advice.



If an applicant has not achieved all essential SpR competences to the level of wholly independent practice as an anaesthetist, the College advises on how to remedy these deficiencies for the purpose of inclusion on the RMS. This advice will likely be in the form of eligibility to apply for a period of further training at the SpR 4/5 level.

The Credentials Committee also assesses applicants for Full registration on the Medical Register. The Committee requires two years in recognised training posts with satisfactory ITA's and completion of the Initial Competence Test in Anaesthesia. The Committee then awards a Certificate of General Professional Experience which the applicant forwards to the Medical Council to achieve full registration.




#### COLLEGE OF ANAESTHETISTS

The Medical Council have now confirmed that non EU Doctors wishing to be admitted to temporary registration, must undergo TRAS (Temporary Registration Assessment Scheme) unless they are exempt from doing so, by possessing a recognised EU primary medical Qualification or higher qualification. Doctors can no longer be exempt from TRAS on the basis of entry onto a recognised postgraduate training programme. At the present time therefore the College of Anaesthetists cannot sponsor any new section 7.6 trainees after July 2008. A submission on International Collaborative Training programmes in anaesthesia has been submitted by the College of Anaesthetists and will be considered by the new Medical Council.



Over the next 6 months recruitment of foundation fellows will begin. Foundation status will cease to exist by January 2010, by which time all foundation fellows will be required to submit a dissertation to be awarded the fellowship of the faculty (FFPMI).

The Pain Medicine Diploma is an integral component of the faculty. To be eligible to apply for a fellowship candidates must pass the Pain Diploma, have 12 months training in Pain Medicine and submit a dissertation.

This year the written papers plus the vivas of the Pain Medicine Diploma will be hosted in Dublin with the clinical component at a Dublin hospital.

# MASTER OF SCIENCE IN MEDICAL PROFESSIONALISM (ANAESTHESIA)

The Master of Science in Medical Professionalism (Anaesthesia) was approved by the Royal College of Surgeons (RCSI) and the Senate of the National University of Ireland in November 2002. The degree was re-named, Master of Science in Medical Professionalism (Anaesthesia) in 2007.

The initial target audience included consultants in anaesthesia in Ireland, post fellowship registrars and anaesthetists listed on the Specialist Register.


The educational objectives were to enhance the education and professional development of consultants and post fellowship registrars with reference to developments in medical education; and to enhance the quality of patient care by providing participants with specific knowledge and skills relating to the ethics and legal aspects of medical practice. The course duration was for a minimum of two and a maximum of five years, part-time study. The curriculum was designed on a modular, part-time basis consisting of eight taught modules, including Legal Medicine, Critical Events, Applied Anatomy, Basic Principles of Clinical Research, Medical Education I and 2, and Biostatistics. Individual modules were available to participants either on site or by distance learning or both. Enrolment commenced in July 2003 with thirteen graduates conferred in 2005.

The original template for the MSc envisaged that the number of modules offered would increase over time so that individuals could select those most appropriate to their interests and projected future role as consultants; and that the College might broaden the eligibility criteria to attract other medical professionals or non-medical health care workers. The College has now expanded this programme to facilitate either undertaking the two-year programme and graduating with an MSc, or undertaking individual or combined modules e.g. Biostatistics Module or Medical Education Module. Such structured education will be allocated CME points reflecting the education / learning hours devoted to such a module. Enrolment for the next course will commence in September 2009

# ACADEMIC ANAESTHESIA COMMITTEE REPORT

The College established an Academic Anaesthesia Committee under the chairmanship of Prof Anthony Cunningham at the June 2007 Council meeting.

The establishment of the Academic Anaesthesia Committee was prompted by recent developments including:

- The Medical Practitioners Act 2007
- Establishment of the National Committee on Medical Education and Training
- HSE SpR Training abroad and HEA/HRB PhD programmes
- Clinican Academic posts


Membership of the Committee includes professors, senior lecturers and academic staff representatives of University College Dublin, University College Cork, NUI Galway, Royal College of Surgeons in Ireland, University of Limerick and Queen's University Belfast.

#### **ACTIVITIES**

The Committee met on 19th September 2007 and 14th November 2007 in the College of Anaesthetists with videoconference links to University College Cork and NUI Galway.

## **A**GENDA

The Committee considered reports from the National Committee on Medical Education and Training and its sub-committees, Undergraduate Sub-committee, Intern Sub-committee and Postgraduate Sub-committee, from its representatives Dr Ellen O'Sullivan and Prof Anthony Cunningham.



The Committee considered a number of new initiatives including HSE-funded SpR training abroad programme. Two candidates were submitted by the College to an expert panel for consideration for the training abroad experience.





Prof John Laffey (NUI Galway) briefed the Committee on proposals to create a combined CST/ PhD programme in anaesthesia. Trainees currently interested in pursuing a career in academic anaesthesia must complete a minimum of two years at BST level, five years at SpR (of which one can be in research) and then a 3-4 year PhD programme. To produce a cohort of clinical scientists in anaesthesia, intensive care and pain medicine a streamlined training programme, integrating clinical training standards that meet CST in anaesthesia with a PhD research programme within a shorter time, has been proposed.



The Committee considered the Postgraduate Training Forum audit evaluating GPT/ BST training posts which categorised them into part of rotation/ stand-alone posts approved by training bodies/ stand-alone posts not approved by training bodies.

The College undertook Care of the Obstetric Emergency and Trauma courses in Mangochi and Blantyre in January and November 2007. Representatives of the College met with Ministry Officials, Irish Aid and the College of Medicine in Blantyre in preparation for submission of a detailed document to Irish Aid in support of a three-year education and training programme in Malawi "Education Assistance in the Management of Trauma-related and Obstetric Emergencies in Malawi with a Focus on Thyolo and Chinadzulu District Hospitals."

# HONORARY TREASURER'S REPORT



I am pleased to report that the College remains in a sound financial position. The Finance Committee, the members of which are listed above, meets at least four times each year. The Committee is directly responsible to College Council and any elected member of College Council may attend the Finance Committee meetings. The overall strategy is to ensure that the financial methodologies are sufficient to allow the College to fund its activities and develop and expand according to its goals. The Auditors Report for 2007 was approved and adopted by College Council in March 2008. OCMC, as College auditors, are independent auditors who work in compliance with standards issued by the Audit Standards Board. Please see the table of contents for the summarised accounts while a more detailed report is available on request from the College.

Turnover has increased by €335,192 (16%) from €2,140,658 in the year ended 31st December 2006 to €2,475,850 in the year ended 31st December 2007. Our Auditors recommended that we changed our account reporting practices in 2006 from reporting on a cash receipts basis to the financial year in which the relevant event takes place. This change in accounting practice affected the exams and courses income in 2006 and in 2007. The operating surplus in the year ended 31st December 2007 increased by €243,131. The main income streams of the College, in addition to Fellows' subscriptions, continue to be grant income from the Postgraduate and Medical and Dental Board, surplus from College examinations and project-based funding directly from the HSE. While it is likely that the PGMBD will be absorbed into the HSE in the near future, it is anticipated that funding for training will continue via the HSE. It is noted that an annual Trainee registration fee is now applied by other postgraduate training bodies which is reimbursed via the training grant provided for in the NCHD contract.



The operating costs of the College increased by  $\in$ 127,054 (8%) from  $\in$ 1,528,103 in the year ended 31st December 2006 to  $\in$ 1,655,157 in the year ended 31st December 2007, due in part to an increase in educational activities run by the College. The College is also embarking on a redevelopment of IT infrastructure including database and web-based services which will increase expenditure but also enhance services to fellows and trainees. A subscription increase has been approved for 2008. Direct debit mandates are extremely helpful in processing subscriptions and I would encourage all Fellows to avail of this facility. We have reduced fees for some categories including Fellows based outside the EU and have waived the subscription for retired fellows.




#### COLLEGE OF ANAESTHETISTS

The building at Merrion Square accounts for our most significant financial asset. The mortgage was cleared in 2006 and cash surpluses were retained on deposit with the most favourable interest rates available. The College will embark on a major Capital development of the premises at Merrion Square in 2008, which will result in an as yet undefined significant financial outlay for the College. The College will remortgage for the proposed next phase of building at Merrion Square, which will see enhanced on site educational facilities for Fellows and Trainees. The proposed development will require financial support and effort from Fellows and supporters of the College and fundraising for this project will be a major focus for the Finance and Fundraising Committees in the near future.

I conclude my second report as Honorary Treasurer with thanks to the members of the Finance Committee for their contributions during the year. I would also like to thank Margaret Jenkinson, our Finance Officer, who deserves special recognition for her efforts and contributions.







## **INCOME (2007)**

The College continues its role in CME by approving credits to educational activities of Fellows.







Council of the College of Anaesthetists May 2007






