PRESIDENT'S REPORT



This is my third and final report in my capacity as President. I am amazed at how quickly the time has moved on. I am very honoured to be President and I hope during my three years I have represented all our Fellows and Staff to the best of my abilities. Outlined here are some of our main activities in the last year.

Council Elections

The following Council members completed their term of office: Dr Harry Frizelle, Dr Saad Mahdy and Dr Jacinta McGinley. I would like to extend our thanks to them for their work on behalf of Council. We also welcomed new members, Drs Gerry Fitzpatrick, Donal Buggy, Ehtesham Khan and Padraig Sheeran. I wish them every success as they take up this new role in the College. In addition Dr John Darling was co-opted onto Council as a representative from Northern Ireland.

Council business

As you see from this year's annual report, the College has had another very busy year with a continued expansion in our activities. Council met on seven occasions in 2014. The key areas of activity and change are outlined below. The audited accounts are contained within this report and show the College finances are in a healthy position at present. Dr Kevin Clarkson, Honorary Treasurer, and Ms Margaret Jenkinson, Finance Officer have

ensured that all departments operate within budget. I would also like to acknowledge the input of our auditors, Grant Thornton. In 2014, the College was in a position to pay all remaining monies due on its mortgage. While, the financial outlook remains uncertain, the fact that the College is now debt free will allow us increase investment in key areas of training, education and assessment which will benefit our Fellows, members and trainees. It is however, critically important that we remain observant and ensure tight financial constraint for the coming future.

CEO

The CEO and his team have had another busy year. The College's activity levels continue to grow both at home and overseas.

In April 2013, the College signed a contract with Medical Validation Ireland (MVIRI) to revalidate 67 Consultant Anaesthetists at the Hamad Medical Corporation in Qatar. This was an 18 month project undertaken with 6 other Irish Training Bodies, all operating under the umbrella of MVIRI. The first phase of this project has now been completed and I would hope that MVIRI as an entity will continue with the College playing a major role in future project initiatives.

Our Overseas Centres continue to expand and in particular Malaysia and Oman. In 2015, the College will welcome 5 trainees from the Omani Medical Specialty Board

who will undertake Clinical Fellowships here. This is an exciting development for the College as we expand our overseas activities. In 2014, I also had the honour of signing a Memorandum of Understanding with the Hong Kong College of Anaesthetists. In the coming year, both Colleges will explore areas for collaboration and to develop stronger links. Such relationships are important as the College continues to explore areas for potential growth. At home, the CEO has continued to professionalise all our operations and has put in place a revised administrative structure. This provides staff with a greater understanding of what is expected of them based on a list of key competencies. The Performance Review process for administrative staff has also been changed to better reflect current business practice.

Working with a tightly group of committed staff, the CEO continues to develop the college's activities and income streams to ensure the College can deliver on its mission to provide high level of training and education to all its stakeholders.

Strategic Initiatives

Over my term of office, we have had two strategic reviews. It was clear from those that for the College to improve its delivery of training and assessment, that a certain level of expertise was required. I am very pleased to advise and indeed to welcome Dr Josephine Boland as the College Medical Educationist

who in a very short period of time has made a major impact. Dr Boland working with the Director of Training, Dr Philip Hawthorne and other key stakeholders is working on the delivery of our Competency based Training Programme and its assessment in the workplace.

In December 2014, I had the pleasure of signing a Memorandum of Understanding (MOU) with University College Cork (UCC). The MOU was co-signed by Prof Michael Murphy, President of UCC. The College will work with the Assert Centre to develop a proficiency-based training programme for the Vascular Access Workshop currently offered to College trainees.

The aim of this initiative is that ASSERT with CAI will apply the proficiency-based training model by adapting the current Vascular Access Workshop offered by the College in order to achieve a superior skill set for central venous catheter (CVC) insertion amongst anaesthesia trainees.

I view such initiatives as being extremely important. At present our Specialty is hugely popular and in great demand by young trainees. However, we must never stand still to guarantee that the "best and brightest" of Graduates want to apply for our training programme.

In respect of the Joint Faculty of Intensive Care Medicine and the Faculty of Pain Management, I would like to congratulate both on receiving specialty recognition from the Medical Council. This is a

very important step in the growth and further development of both Specialties and the College looks forward to working with both in a collaborative manner for many years to come.

Professional Competence

The College of Anaesthetists of Ireland was charged under The Medical Practitioners Act 2007 with administration of a Professional Competence Scheme (PCS) and an agreement was signed with the Medical Council in 2011 to implement a PCS for registered doctors aligned to the specialty. The scheme was developed in liaison with the Forum of Irish Postgraduate Training Bodies resulting in a broadly similar process across all training bodies.

The PCS year runs from 1st May to 30th April each year. The College is very conscious of the increasing financial pressure on our members and therefore we endeavour to retain the fee at the most reasonable level possible. The annual fee covers the cost of investment by the college in software, administration and database management. Dr Camillus Power was chair of this Committee for the first half of 2014 and Dr David Mannion for the second half. I would like to thank both Chairs for their excellent contribution to this increasingly important college activity.

Education

The Education Committee, chaired

by Dr Brian Kinirons has had another excellent year in increasing the number of educational activities offered by the College, with particular attention to covering the eight domains of practice required by the Medical Council. The Committee met five times during the year.

The Annual Congress was held in the Convention Centre Dublin for the fourth year in a row in May 2014. Over 400 delegates attended over the two days at this very successful Annual Scientific meeting. The meeting covered a broad range of topics including sessions devoted to paediatric anaesthesia, patient safety, pain medicine, perioperative anaesthesia, and ethics and professionalism. The Irish Society of Regional Anaesthesia (ISRA) held their Advanced Ultrasound in Regional Anaesthesia Workshop. The Congress faculty included speakers from Northern Ireland, UK, Europe, USA, Canada, Hong Kong and Ireland.

This is the second year the College has run the Essay competition for Undergraduate students. The title of the essay was 'Anaesthesia - Past achievements, future challenges'. We received 27 submissions and awarded 1st, 2nd and 3rd prizes which were announced at the Annual Congress in May.

In 2014 the College held a CAT Consultant Interview Workshop. This is the first year the College ran this workshop which was coordinated by the CAT Committee and was held on the 28th April. The workshop is designed to improve a candidate's interview skills and help with CV preparation. It was very successful and will be held again in 2015.

The College wishes to support educational activities across the country with the regional societies

to ensure that all meetings are not based solely in Dublin. This is also a key part of the College's strategy. In addition and in the coming year the College will invest in the technology needed to allow our Fellows access to key educational activities without having to be present at same in Dublin.

Training

Training remains the core business of the College. The Training Committee was chaired for the first 6 months of the year by Dr David Mannion and the second six months by Dr Camillus Power. The College of Anaesthetists of Ireland is the sole postgraduate training body responsible for anaesthesia in Ireland. It is recognised as such by both the Irish Medical Council and the HSE NDTP as SpRs who successfully complete training are awarded a Certificate of Completion of Specialist Training and are thus eligible for registration in the Specialist Division of the Irish Medical Council register.

While the new SAT scheme commenced in July 2012, the pre-existing SpR continues to run in parallel. SpRs taken on prior to 2012 will remain on our training scheme until 2017 when the final SpRs achieve CST status. Running two different groups of trainees remains a logistical challenge for the Training Office and I personally would like to thank all who have been very active in ensuring that we now have a very successful training programme. In particular, I would like to formally acknowledge the work undertaken by David Mannion who through his energy and foresight has provided the College with probably the most innovative and pop-

ular training programme available in Ireland.

The Chair of Training, the Director Training and CEO have on-going interaction with HSE NDTP in relation to training issues and funding. The CAI agreed a new Service Level Agreement with the HSE in respect of delivery of anaesthesia training programmes for our trainees, commencing July 2014 for 1 year. These SLAs dictated the numbers to be employed on the College's Training programmes and mandatory deliverables which the College would provide, around these training programmes.

The CAI is acutely aware that while we control and direct training, most of the clinical training occurs at hospital level. We acknowledge the significant work of the tutors on behalf of the trainees. Furthermore we support the need for protected time to deliver this function. It is essential therefore that the views and feedback of clinicians who conduct training are represented to the Training Committee. Dr Patricija Ecimovic has taken on this role in 2014 and will continue for the next year.

As part of the ongoing development of our training programmes the CAI recognised that there were opportunities to develop supra-specialty interest in a number of areas including Intensive Care Medicine, Pain Medicine, Obstetric Anaesthesia, Paediatric Anaesthesia and Cardiothoracic Anaesthesia. The HSE NDTP has approved these posts and it is hoped to commence appointments for 2015/16.

At this point, I would also like to personally acknowledge Dr Ian Surgeon who retired from the College as Dean of Postgraduate Training in 2014. Ian was the "soul" of the College and led our Training programme along with many other areas of college activities into the 21st century. He is a person we will never be able to replace and as a colleague and friend, I thank him for his substantial contribution to the College. I would also like to acknowledge Dr

Ellie O' Leary who held the post of Director of Trainee Affairs. Finally, under training I would like to welcome Dr Philip Hawthorne to the College as Director of Postgraduate Training and I look forward to working with Philip in the next exciting phase of the development of our 6 year SAT Programme.

Committee of Anaesthesia Trainees (CAT)

The primary function of CAT is to represent trainees on all College of Anaesthetists of Ireland committees in which matters dealing with training are discussed. CAT, which is chaired by Dr David Moore has been particularly involved in the activities of the Training and Education Committees, and their representatives also contribute to Finance and Examinations Committee meetings.

In addition to participating in the Standing Committees of the College, CAT were very actively involved in the Medical Careers Day held at Dublin castle. This event (organized by the Forum of Postgraduate Training Bodies) was designed to allow medical students and interns an opportunity to find out about the various options for medical specialty training in Ireland, and to get the "lowdown" from trainees and consultants in each specialty. CAT also organized the Anaesthesia Information Day held in February to allow a more in-depth experience of the multitude of roles played by anaesthetists in our hospitals. This event was attended by Undergraduates and Interns who had an interest in pursuing a career in Anaesthesia. It was a highly successful day.

Since the formation of CAT, they have become one of the most successful and innovative committees in the college. Their ongoing in-

Examinations

Dr Anne Hennessy chaired the Examinations Committee in 2014. In the last year the Committee met on

5 separate occasions. The Examinations Office has embarked on an ambitious project to streamline the management of the examination system using customised software from the Ripley Systems. This project is now complete.

Following a review of all aspects of our methods of assessment and with the advice and input from our Medical Educationist, Dr Josephine Boland, some structural changes will be made to the final fellowship examination in 2015.

Over the past year we have formed a number of panels to oversee and review each section of the membership examination. This is working well especially in the MCQ. A great deal of work has been done to ensure a relevant, up to date and robust question bank.

We will continue to review all aspects of our examinations including their quality assurance and will make appropriate changes to ensure we meet the highest standards attainable. We have been fortunate that we have had a number of new examiner applications in 2014. All new examiners continue to observe each examination and undergo examiner training prior to commencing formally as a College examiner.

Examinations are one of the key activities of the College both at home and overseas and I am very grateful to Dr Hennessy and her team for running examinations to a level that represent the highest standards of the College. I am also very grateful to those who give up of their time to examine for the College and I thank you for same.

Credentials

Dr Frank Loughnane chairs this Committee. The Committee has met on 6 separate occasions in 2014. The Committee reviews applications on behalf of the Medical Council for the purposes of Registration as a Medical Specialist. The Committee is guided by the Medical Practitioners Act 2007 and European Directive 2005/36/EC. Candidates are assessed for competence in clinical modules as well as in nonclinical competencies as outlined in the college document "Competence in Professionalism for Independent practice". In total 13 applicants were recommended for inclusion onto the Specialist Register. Five of those recommended for inclusion had successfully completed a period of structured training which was recommended by the Committee. A further three applicants who applied during 2014 were recommended to undertake further substantial senior level of training.

The role of The College is advisory and the Medical Council makes the final decision on eligibility for inclusion on the register of medical specialists. The Medical Council have an appeal process for doctors whose applications are refused. The Committee also assists College Council with applications for Ad Eundem fellowship of the College.

Over the last 18 months the Medical Council have been working with the Forum of Postgraduate Training Bodies to establish a revised framework for assessing doctors for entry to the Specialist Register. This new structure will provide a commonality of approach across all training bodies and will also ensure a standardized approach. The Training bodies have signed a service level agreement ti-

tled "Agreement for the Provision of Services in relation to the Assessment of Applications for Registration in the Specialist Division of the Register of Medical Practitioners" with the new process commencing in 2015.

Overseas Developments

The College has supported the training of 3 anaesthetists in Malawi on the MMed programme in Blantyre, all of whom have now completed their training. Dr Gregor Pollach, head of department in QEH, assisted the trainees in completing research and audit projects. I am personally very grateful to Dr Pollach for his dedication towards ensuring the success of this important initiative for both the individual trainees but also in improving the quality of care in Malawi. In August 2014, over 100 Clinical Assistants attended an Oximetry Course run by the College with the support of Lifebox. I think it should remain a priority of the College to continue with its work in Malawi and indeed to expand its activities with the aim of improving patient care.

As has already been referred to, the College's overseas activities have expanded further in 2014. I think it is very important that we continue to develop our activities outside of Ireland in addition to our primary activities here. I think it is important that the College sees its boundaries not only within Ireland. There is a great demand for quality education and qualifications and working with the CEO and Executive, I would hope that we can expand the reach and influence of the College.

Academic Committee

In my time as President, I was always of the view that the College

needed to better co-ordinate its academic and research activities but more importantly to develop same as a key strategic aim of the College. I was very pleased that this new committee did emerge in 2014 under the excellent direction and guidance of Dr Donal Buggy as Chair. Its remit includes providing competitive, peer-reviewed funding opportunities for quality research and major audit, and also advocacy for development of academic units in the specialty in Ireland.

The committee launched a call for a project grant offering funding of up to €70,000 which clearly shows the College's commitment to developing a strong research ethos. The Committee worked tirelessly to put an appropriate structure in place for applications for this grant and it is hoped that the recipients of same will be announced at Congress in 2015.

The committee has also embarked on discussing further initiatives which may be launched to support research and audit on either a large or small scale.

Quality and Safety Advisory Committee

In 2014, Dr Gerry Fitzpatrick assumed chair of this Committee from Dr David Honan. I would like to thank David for all his hard work in further developing the role and remit of this key college committee. The purpose of this Committee is:

1. To consider such matters pertaining to Quality and Safety as may be referred to it by Council.
2. To provide advice in matters of professional practice and standards to external agencies, where appropriate.
3. To promote the development and implementation of best practice in anaesthesia, intensive care and pain medicine.
4. The Committee may consider Quality and Safety matters other than those referred directly by Council, if it deems them appropriate.

I think it should remain a priority of the College to continue with its work in Malawi and indeed to expand its activities with the aim of improving patient care.

During the course of 2014 the Committee liaised closely with the Forum of Irish Postgraduate Medical Training Bodies Working Group on Quality & Risk in the development and drafting of the document 'Investigations of Adverse Incidents: Guidance Document for Postgraduate Medical Training Bodies'. This guidance document will be completed and submitted to the Training Bodies for approval in the first quarter of 2015.

The Committee are also working on the development of a strategy for the implementation of key recommendations from the NAP5 report that apply to CAI.

I would like to thank Dr Fitzpatrick for taking on this task and bringing his experience, energy and intellect to same.

Lay Committee Members

In June 2012, the College appointed 10 Lay Representatives to all of its Standing Committees. This group all play a very important role in attending our Standing Committees. As a cohort they provide an independent, external perspective and infuse the College's committees with fresh, new thinking on all aspects of activities. It was my first task as President to welcome them to the College and in my three years, I have seen the significant role they play. I have no doubt that they are now a permanent part of the College's fabric.

National Anaesthesia Programme

The National Clinical Programme in Anaesthesia has been established, under the Directorate of Quality and Clinical Care. Dr Bairbre Golden was appointed Director in December 2011. The College is represented on the Advisory Group by the Honorary Secretary and the CEO of the College. I chair the Advisory Committee. In its short existence, the NCPA has worked tirelessly to drive improved patient care, change and efficiencies in the

healthcare system. Dr Golden completed her term as Director at the end of 2014. In September 2014, I was appointed as Deputy Chair of the Forum.

The Forum and Executive met nine times in 2014. There were four Tripartite meetings with the IMC, HSE NOTP and the Forum.

I would like to thank the CEO and the administrative staff for their professionalism, dedication and hard work in the last year. I would also like to acknowledge and thank Dr Crina Burlacu, Director of Simulation Training for Trainees and Ms Louise Kelly, Nurse Administrator for providing the highest level of simulation teaching and training to our trainees.

I would like to thank the members of Council, particularly the Honorary Officers and Chairs for all the time they give to the work of the College. I would also like to thank them for their support and encouragement in my role as President.

CEO'S REPORT



This is my third complete year as CEO. When writing for the Annual Report, it always provides an opportunity to reflect on the year past, to acknowledge what has been achieved in that time and to outline the challenges that lie ahead. Alarming, it also reflects how quickly the last three years have gone.

Each year I make reference to the environment and undoubtedly it remains challenging. While the economy may be improving slightly, this is not necessarily reflected within the health sector nor in our ability as a nation to retain our highly competent trainees when they complete their training. This has to remain a very serious issue which the College through the mechanism of the Forum will work tirelessly to improve. However, we still have some way to achieve success.

Highlights

In the last three years, in conjunction with the Council and Executive of the College and using our Strategic Workshops as a catalyst for development and change, the College has introduced a number of new initiatives. I have mentioned some of these previously but

I would see the highlights being the establishment of the Membership Examination (MCAI) which brings the College's award more in line with other training bodies both in Ireland and the United Kingdom and is appropriate recognition for what is a high stakes examination; the growth of our overseas activity; our role within Medical Validation Ireland; the increasing prominence of the College within the Forum, with the President as Deputy Chair and my role as Chair of the International Medical Graduate Training Committee.

Everything we do as a College is on behalf of our Fellows and trainees who are the bedrock of this institution. Growing an institution while not an easy ask, can only be done if we have "buy-in" from our key constituents and all view it as being to their benefit from a professional perspective. I hope we are achieving that.

Since commencing my role as CEO, I have attempted to broaden the College's exposure to include activities in a number of overseas centres. In this time, we now have established examination centres in Oman, Malaysia, Jordan and Egypt. The College is providing expertise

in many areas including examinations, training, simulation, assessment and curriculum development. The College has much to offer and it is in great demand. We have established an International Faculty and in the coming months will put in place a permanent secretariat to oversee the administration. Our overseas activities have to be seen to benefit what we do at home and nor can they put in jeopardy our main activities of training and education in Ireland. However, on a personal level it makes me very proud when I hear the college being held in such high regard in many corners of the world.

In April 2013, the College signed a contract with Medical Validation Ireland (MVIRI) to revalidate 67 Consultant Anaesthetists at the Hamad Medical Corporation in Qatar. This was an 18 month project undertaken with 6 other Irish Training Bodies, all operating under the umbrella of MVIRI. The first phase of this project has now been completed and I wish to acknowledge with thanks all those who assisted in delivering the revalidation from the College's perspective. The entire process was superbly managed by Dr Ian Surgeon. The challenge for MVIRI and indeed the college as one of the key participants is to achieve sustainability around such programmes and in the coming year, considerable effort will be made to obtain new and exciting projects.

the need to employ expertise in the areas of medical education and Information technology. I am very pleased to welcome Dr Josephine Boland as our Medical Educationist who has “hit the ground running” and already has played a significant role in the ongoing development of our competency based training curriculum and review of our examinations. The College’s aim in the coming years is that we achieve and are recognised as such for best practice in training and examinations, both nationally and internationally. Dr Boland’s expertise and knowledge will go some way in helping us achieve that.

While progress has been a little slower in respect of IT, we now have full-time support in the college and this has already made a significant improvement. In the last year, we have also developed our Facebook page which has grown in popularity by almost 500% in a very short period of time. We are also assessing if other methods of social networking will help us to engage at an increased level with our Fellows. In the coming months, we intend making a substantial investment in the area of webcasting and podcasting as part of this initiative.

In my opinion the College must always be at the forefront in developing new methodologies in assessment, education, etc. With this in mind, the President, Dr O’Sullivan signed a Memorandum of Understanding with University College Cork where we will work with the Assert Centre

to develop a proficiency-based training programme for the Vascular Access Workshop currently offered to College trainees.

The aim of this initiative is that ASSERT with CAI will apply the proficiency-based training model by adapting the current Vascular Access Workshop offered by the College in order to achieve a superior skill set for central venous catheter (CVC) insertion amongst anaesthesia trainees. I would hope this is just the start of the development of a long term relationship and collaboration with ASSERT.

In the last year the College has undertaken an extensive review of its Masters Programme which is now titled the MSc in Professionalism for Medical Specialists. This revised programme reflects new educational thinking and practice. I would like to thank both Dr Joseph Tracey and Dr Barry Lyons for their considerable assistance, support and expertise in the redrafting which will now be submitted to the National University of Ireland along with our submission for Degree Awarding status. We hope that we will be able to launch the new Masters later this year.

The lifeblood of the organisation is the staff and the College is lucky to have a highly professional and efficient cohort of people working for it. In the last 12 months, the staff development programme has continued with the aim of ensuring that we operate collectively which is essential in an organisation with a

relatively small support team. I am grateful to Council for their continued support in this area.

In 2014, the College introduced a new administrative structure in line with best industrial practice. It is more streamlined and clearly shows for each staff member what competencies and level that need to be achieved for them to be in a position to progress from grade to grade. I am also happy with the progress being made towards the establishment of a permanent governance structure within the administrative side of the college and which I hope will serve the college well for many years to come.

2015

As CEO of the College, my main focus in 2015 will continue to be to further embed and in-act the College strategy. In addition I will continue to strive to strengthen the College’s finances primarily through increased overseas activity. This year will also see the restructuring of the Postgraduate Dean’s Office to ensure that we have the relevant expertise and support needed to deliver on our training programme. As we enter a period of transition with the appointment of a new President in May 2015, it is my role as a CEO to ensure that there is a seamless transfer from Dr O’ Sullivan to the next President.

The College continues to be in a healthy position both financially and structurally. The challenges remain and the interactions with HSE

NDTP, Department of Health and Children and the Medical Council are at times difficult and strained as we always engage with them with the best interests of the profession, trainees and fellows. This we will continue to do in 2015.

I would personally like to thank Dr O' Sullivan whose three year term as President comes to an end in 2015. Dr O' Sullivan has been a wonderful person to work with and has brought the college to a new level both at home and overseas. It has been an enormous pleasure to work with Dr O' Sullivan whose intellect, energy and enthusiasm have been a key component in the further development of the College.

I would also like to acknowledge the work of Dr John Loughrey whose term of office as Honorary Secretary will come to an end in 2015. I have learnt hugely from working with John whose capacity to understand the most complex legal basis under which the college exists never ceased to amaze me. I would also like to acknowledge the Honorary Treasurer, Dr Kevin Clarkson for his support on various College initiatives, but also most importantly his advice at all times.

The Staff

I have stated this year in my report and will restate the importance of the college becoming the of the College becoming an employer of choice so as we can maintain the high quality of administrative support that currently exists within the College.

In 2014, two new members of staff joined the College:

- Dr Josephine Boland (Medical Educationist)
- Mr Colm Carney (Maternity cover).

In 2014, Dr Ian Surgeon, Postgraduate Dean retired from the College. Dr Surgeon's major contribution to the college's development at every level is unquestionable. In my time as CEO, he has provided the knowledge, expertise and indeed support which has helped me undertake my role. Dr Surgeon will be an impossible act to follow as his skill-set covered everything from training to simulation to IT and more. Even in retirement and for the foreseeable future the College of Anaesthetists and Dr Surgeon will be inextricably linked.

I would like to acknowledge the contribution of Council and Committee members for their role in ensuring the continued provision of high quality anaesthesia services in Ireland. Finally, I would like to sincerely thank all the staff at 22 Merrion Square for their hard work, enthusiasm and dedication in supporting the business of the College.

DIRECTOR OF TRAINING'S REPORT



In August 2014, I was honoured to be appointed as Director for Postgraduate Training. This was a new role created as part of the overall restructuring of the Postgraduate Training Office. For the first three months of my new job, I was indebted to the support and advice offered by Dr Ian Surgeon and I very quickly realised that Ian is a person who can never be replaced. The College owe Ian a huge debt of gratitude for providing us with a wonderful training programme.

This year was a period of consolidation as we continue to implement the far reaching changes in Anaesthesia training which were introduced in 2012. What this meant was a reduction in training duration by one year to six years and the designation of these years as SAT 1 – 6 (Specialist Anaesthesia Trainee); restructuring of SAT 6 to allow for Special Interest or Fellowship opportunities; a dedicated pathway from SAT 2 to SAT 3 allowing for transition with interview, provided CCSAT2 is achieved, and a change in post numbers to better match the numbers in SAT 2 thus removing the traditional bottleneck that previously existed at this point.

While the numbers on the National Training Programme are increasing (now 40 p.a.), there has been a sizeable decrease in the numbers of non-training NCHDs. This creates additional pressures on Consultants and trainees and leads to increased tension between the demands of service and train-

ing. This is further exacerbated by the implementation of the European Working Time Directive. The Training Bodies are collaborating with the HSE and the Medical Council to reduce this gap through the International Medical Graduate Training Initiative (IMGTI). This Committee of the Forum, chaired by the College CEO, Mr Fintan Foy, sets out the requirements and mechanisms by which overseas trainees can come to Ireland for two years to further their training. The first output of this process has been the identification of doctors who are currently undergoing training in Anaesthesia with the College of Physicians and Surgeons, Pakistan. These doctors can come to Ireland for two years in the middle of their training and then return to Pakistan to complete their training. To date, there are 21 doctors working within this programme. In July, the College will welcome a further five doctors from Oman who have completed their training and will undertake two year Clinical Fellowships as part of this programme.

In 2013, Dr Surgeon undertook a comprehensive and major review of all competencies required for CST in Anaesthesia, Intensive Care and Pain Medicine. This was a huge body of work, which the College are now taking to the next phase; this is the implementation of the competencies based training together with objective measurement of that training through Work Based As-

essment. A working party has been set up consisting of Trainers, Tutors and Trainees. We are being guided and instructed by the College Medical Educationist, Dr Josephine Boland. In my opinion, Dr Boland's appointment in late 2014 will prove to be one of the most critical and strategic appointments the College has made in some time.

The CAI Simulation Training Unit continues to go from strength to strength with more courses being offered and with continuing academic output. The staff of Dr Crina Burlacu and Ms Louise Kelly as well as the excellent administrative support from the College and the input from Simulation Fellows and Simulation Trainers have worked extremely hard to ensure its success.

In a very short period of time, I was provided with the opportunity to work within one of the key pillars of the College – training. I have also had the opportunity to liaise and work with a new cohort of people; I would particularly like to mention the College Training officer, Ms Maria Golden, who supported me at all times and greatly enhanced my knowledge of all aspects of the College training programme.

Indeed, I must acknowledge all those who have supported me and helped me to take on this critical function within the College. While short, it has been very enjoyable.

EXAMINATIONS ANNUAL REPORT

It gives me great pleasure to present my first annual report as Chair of the Examinations Committee. I would like to start by extending my thanks to my predecessor Dr. Philip Hawthorne who has been a great support to me in my new role as he remains as Chair of the Final Fellowship Examination. The Committee met formally 5 times during 2014 but as always a great deal of work was carried out by all members of the committee, and others, in their own time throughout the year.

Membership Examination

MCQ There were 3 sittings of the MCQ component of the examination during the year. The examination ran concurrently in 4 centres - Dublin, Oman, Jordan and Malaysia in January and June and in September there was a 5th centre in Egypt. A total of 235 candidates sat the MCQ paper in 2014 of whom 130 were successful. **OSCE / SOE** There were 2 sittings of the OSCE / SOE part of the examination in Dublin. 94 of 127 (74%) candidates taking this part of the examination were successful. Dr. Susan Bailey from the RCoA attended the autumn sitting of the examination as the Exchange Examiner. Dr. Baileys role was one of quality assurance only. **Fellowship Examination** 208 candidates sat the final fellowship examination during the year. 116 (55.76%) were successful. Dr. Stuart Collins attended as the Exchange Examiner at the spring examination.

New developments

Our Medical Educationalist Dr Josephine Boland was appointed last year and took up this part-time post before Christmas. She has already made a significant contribution to the work of the Examinations Committee and I look forward to continuing to work with her.

Some structural changes have been made to the final fellowship examination and at the spring 2015 sitting of the examination the MCQ paper will increase in length from 1.5 to 2 hours. The

number of questions will increase from 40 to 60 (each with 5 stems). The written paper will remain at 3 hours but will contain 10 SAQs now instead of 8 SAQs and 2 long questions.

We hope to introduce Single Best Answer (SBA) questions to the final fellowship examination during 2015.

Over the past year we have formed a number of panels to oversee and review each section of the membership examination. This is working well especially in the MCQ. A great deal of work has been done to ensure a relevant, up to date and robust question bank. My thanks to all examiners involved. We are in the process of extending this to the final fellowship examination.

Examiner recruitment / education

We have been fortunate that we have had a number of new examiner applications in 2014. All new examiners continue to observe each examination and undergo examiner training prior to commencing formally as a College examiner.

The examinations committee ran a very successful Single Best Answer (SBA) question writing workshop in January 2015. Fintan Foy gave us the benefit of his experience in postgraduate examinations and training over the last 20 years. Philip Hawthorne spoke to us about standard setting - what we currently do and our plans for development. Our new Medical Educationalist

Dr. Josephine Boland spoke about quality in assessment. The fourth talk was an excellent discourse on the construction and review of SBA questions by Dr. Anthony McCluskey, immediate past chair of the Primary MCQ examination at the Royal College of Anaesthetists in London. The workshop was very well attended by both membership and fellowship examiners. The examiners spent some time constructing and reviewing clinical questions and they continue to work at this in their own time to try and build up a bank of questions for the examinations. I hope we will be in a position to consider their introduction to the membership examination in 2016.

Dr. Ehtesham Khan, Vice Chair of the membership examination continues to run a number of fully subscribed courses for candidates for each membership and fellowship examination throughout the year.

Overseas

As mentioned previously we have a new membership MCQ examination centre in Cairo. In March 2015 a small delegation from the examinations department will travel to Muscat to run the Membership OSCE and SOEs.

Report of the Training Committee 2014

The College of Anaesthetists of Ireland is the sole postgraduate training body responsible for anaesthesia in Ireland. It is recognised as such by both the Irish Medical Council and the HSE National Doctors Training and Planning Office (NDTPO) and Specialist Anaesthesia Trainees who successfully complete training are awarded a Certificate of Completion of Specialist Training and are thus eligible for registration in the Specialist Division of the IMC register. In 2014 the following doctors achieved CST

Specialist Anaesthesia Training Programme

The new SAT programme commenced in July 2012 with recruitment to SAT year 1 and SAT year 3. There was further recruitment to both SAT year 1 and 3 in 2013. In 2014 there was no recruitment to SAT 3.

SAT Year 1

There was strong competition in 2014 for entry to the new SAT programme. Eighty four applicants completed an online application form and sixty two candidates were shortlisted using a standardised selection process. These candidates were then interviewed and

increased in 2014 at the bequest of HSE NDTP. SAT 1 and 2 was increased to 40 and SAT 3 – 6 was increased to 36. The difference in the numbers is to allow for the attrition rate on the programme.

- Five post CST positions in intensive care medicine and one in paediatric anaesthesia were approved for July 2014. These posts were the conversion of registrar positions to SpR positions and will attract an SpR salary for the incumbents. Two post

CST fellowship posts exist in Pain Medicine one at St James and the other a SVUH /MUH rotation.

- EWTd was introduced in all hospitals. The trainee group (CAT) of the CAI are auditing this and will have results which they will share with all fellows and the HSE in 2015.
- The Irish Medical Council requested a yearly update from the CAI as part of our ongoing accreditation process. The CAI is continuing to work on some of the

issues and concerns of the IMC.

- Work on a new logbook commenced in 2014 and is due for completion in 2015.
- Family Friendly rotations have been introduced and approved by all training bodies including the CAI. The following three components have been agreed:
 - Flexible Training – less than full time training. 50% only. Limited to a period of two years.
 - Job-sharing - A training post can be shared by two trainees who are training in the same specialty and are within two years of each other on the training pathway. Limited to a period of 12 months.
- Family-friendly rotations – Training bodies may consider swapping rotations for a trainee if a trainee complies with one of the categories currently identified:
 - Responsibility for caring for ill/disabled partner, relative or other dependent

Presentations from Professor Eilis McGovern (HSE-NOTP), Professor John Crowe (RCPI and Forum), Dr Ellen O'Sullivan (CAI and Forum), and Professor Freddie Wood (Irish Medical Council) highlighted the recent advances in medical training in Ireland. All the speakers addressed the importance of retaining medical talent. The anaesthesia stand and simulation area was very popular with the delegates. A mixture of college staff, SATs and Consultants were on hand to answer questions the students had about the SAT scheme. Everybody was impressed with the level of interest and enthusiasm from the delegates and it is hoped this will prove fruitful for the continued recruitment to anaesthesia.

Tutors

The CAI is acutely aware that while we control and direct training, most of the clinical training occurs at hospital level. We acknowledge the significant work of the tutors on behalf

of the trainees. Furthermore we support the need for protected time to deliver this function. It is essential therefore that the views and feedback of clinicians who conduct training are represented to the Training Committee. Dr Patricija Ecimovic has taken on this role in 2014 and will continue for the next year. A tutor day will be held in May 2015.

Committee of Anaesthetists in Training.

In addition to the trainers, the Training Committee also benefits from the attendance of representatives of the Committee of Anaesthetists in Training (CAT). The functioning of the Training Committee involves constant dialogue between all interested parties and none are more essential to this process than the trainees themselves. Dr David Moore succeeded Dr Mort Kelleher as Chair of the Committee of Anaesthetists in Training in 2014 and I would like to commend both for their input into the direction and decisions of the Training Committee. Competency Working Group

EDUCATION COMMITTEE REPORT

The past year has been a busy one for the Education Committee with a number of workshops, symposiums, lectures, competitions and some new events and the Irish Congress of Anaesthesia. The Committee met five times during the year on the 10th January, 28th March, 9th May, 18th July and 11th December and reported back to the Council and the President.

College Workshops

This year all of the workshops were very popular and were well attended. The Vascular Access Workshop which is mandatory for our trainees was held on the 17th February and was run by Dr Alan McShane. The Echocardiography Workshop run by Dr Michael Griffin on 28th March. The Local Anaesthesia for Ophthalmic Surgery Workshop was held on the 4th November in the Royal Victoria Eye & Ear Hospital, this is the only workshop in Ireland that has live orbital blocks. This workshop is now mandatory for students of the Irish College of Ophthalmology. Dr Muhammad Mukhtar is the workshop coordinator. The Difficult Airways Workshop was held on the 22nd October and was run by Dr Ellen O'Sullivan and Dr Jubil Thomas. The Professionalism in Practice Workshop was held on the 28th of November in conjunction with the Winter Anaesthesia Weekend and was organized by MSc Professionalism in Practice module coordinator Dr Barry Lyons. Thank you to all workshop organizers who kindly dedicate their time to ensure the success of these meetings.

CAT Consultant Interview Workshop

This is the first year the College ran this workshop which was coordinated by the CAT Committee and was held on the 28th April. The workshop is designed to improve a candidate's interview skills and help with CV preparation.

College Courses

The Introduction to Anaesthesia course which is mandatory for all new trainees on the College training programme was held in the College on the 10th,

Medical Education Symposium

The Medical Education Symposium Day "Practical Skills for Effective Teaching and Learning" was held in the College on the 28th February. The day involved interactive lectures and practical workshops and is targeted at consultants and senior trainees with a special interest in clinical education and in improving their teaching and learning skills. The symposium was organized and coordinated by Dr Enda O'Connor (St James's) and Dr Ruth Fanning (Coombe).

Practical Guide to Awake Fiberoptic Intubation Symposium

The symposium was held on the 28th June in the College and was coordinated by Dr Mark Abrahams and the airways fellow in St James's Hospital. The day includes presentations by local faculty, discussion and an open forum of difficult airway cases.

Abbvie Scholarship

The Abbvie Scholarship in competition was held in the College on Friday 7th March. Abbvie provided €10,000 for scholarship to support original research by an Irish anaesthetist. The judges were Dr Joe Tracey and Prof Martin Leuwer (UK). The scholarship was awarded to Dr Anne Doherty with a presentation entitled 'Apelin, Placental Growth Factor and Soluble fms-like tyrosine kinase-1 at 14-16 weeks gestation in Pregnancies Complicated by early Preeclampsia and/or Fetal Growth Restriction.'

Irish Congress of Anaesthesia (ICA)

This was held on the 16th & 17th May in the Convention Centre Dublin. The meeting covered a broad range of topics including sessions devoted to paediatric anaesthesia, patient safety, pain medicine, perioperative anaesthesia, and ethics and professionalism. The Irish Society of Regional Anaesthesia (ISRA) held their Advanced Ultrasound in Regional Anaesthesia Workshop. The Congress faculty included speakers from Northern Ireland, UK, Europe, USA, Canada, Hong Kong and Ireland. The Sir Ivan Magill lecture was presented by Prof Kathryn McGoldrick, USA Substance Abuse and Anaesthesia Providers –An Occupational Hazard. This year we also ran two very successful lunchtime symposiums which were sponsored by Baxter and MSD. The Annual Dinner was held on the 16th May in the Four Seasons Hotel, Dublin.

Medical Student Essay Competition

This is the second year the College has run the competition. The title of the essay was 'Anaesthesia - Past achievements, future challenges'. We received 27 submissions and awarded 1st, 2nd and 3rd prizes which were announced at the Annual Congress in May. 1st prize was awarded to Ms Aine Varley (UCD), 2nd prizes went to Ms Emma Fanning (UCD) and 3rd prize to Mr Ross Bowe (UCD).

Core Topics Day and Autumn College Lecture

The Core Topics Day meeting was held in the College on the 7th October. Autumn College Lecture was held in conjunction with South of Ireland Association of Anaesthetists Annual Scientific Meeting on Saturday 18th October in the Dingle, Co Kerry. The lecture was presented by Professor Robert Sneyd, Dean of the Plymouth University Peninsula Schools of Medicine and Dentistry. The lecture was entitled "Time to change our practice?".

KP Moore Medal Competition

The competition was held in the College on the 28th of November. The adjudicators were Dr Michelle Duggan (Mayo), Dr Tanya O'Neill (Beaumont) and Dr David Moore (CAT representative). Dr Pierce Geoghegan won the KP Moore Medal for his presentation entitled 'Sodium correction practice in profound hyponatremia: experience in a tertiary referral centre'. CREDENTIALS COMMITTEE REPORT



This is my second report as chair of the Credentials Committee which met on five occasions during the year; 31st January, 25th April, 6th June, 5th September & 27th November 2014. The meetings are attended by other members of council including the President, Dean and National Directive of Training and administrative staff.

The Committee reviews applications on behalf of the Medical Council for the purposes of Registration as a Medical Specialist. The Committee is guided by the Medical Practitioners Act 2007 and European Directive 2005/36/EC. The Medical Council will usually support the college decision but retains discretion. This process allows doctors who have not taken part in the College of Anaesthesia Specialist Registrar training programme to demonstrate equivalence of training and experience. This also includes those applying from abroad within or outside of the European Union. Candidates are assessed for competence in clinical modules as well as in nonclinical competencies as outlined in the college document "Competence in Professionalism for Independent practice".

Applicants may be recommended for immediate registration where documentation is complete and includes substantial and verified evidence of training including rosters, logbooks with a breakdown of caseload and structured references requested by the Committee.

This process allows doctors who have not taken part in the College of Anaesthesia Specialist Registrar training programme to demonstrate equivalence of training and experience.

The Committee introduced new Structured Reference Reports, which are sought from chairpersons of departments, who liaise with senior colleagues in the department. Candidates deemed to be deficient in verifiable components of Specialist Registrar year 4/5 training, may be referred through the training committee for a period of structured training in specific hospitals. It is important that accepting institutions put in place a satisfactory programme for the candidate. These positions are in short supply and availability cannot be guaranteed by the College.

A number of applicants have no demonstrable specialist training equivalent to College training and cannot be supported for registration as a specialist. They may of course seek general registration. A streamlined process is being developed in conjunction with the Medical Council to provide non-eligible doctors with clarity and objectives avoiding undue delays and expense.

Twelve new applicants were referred to the Committee by The Irish Medical Council in 2014. All applicants agreed to progress their submissions to the Committee for their recommendation.

In total 13 applicants were recommended for inclusion onto the Specialist Register. Five of those recommended for inclusion had successfully completed a period of structured training which was recommended by the Committee. A further three applicants who applied during 2014 were recommended to undertake further substantial senior level of training.

The role of The College is advisory and the Medical Council makes the final decision on eligibility for inclusion on the register of medical specialists. The Medical Council have an appeal process for doctors whose applications are refused. The Committee bore witness to three appeal hearing in 2014. The Committee also assists College Council with applications for Ad Eundem fellowship of the College.

I would like to thank college staff, notably Mr. Colm Carney, Ms Orla Doran and Mrs Lauren Donohoe for their support of the Committee.

JOINT FACULTY OF INTENSIVE CARE MEDICINE OF IRELAND

This is a summary of work of the Faculty this year in pursuit of its aims.

1 Intensive Care Medicine (ICM) as a specialty: This news was conveyed by letter on 8th January 2014, work has been slow in effecting the structures and regulatory provisions relating to this decision. The current main two issues are:

Accreditation of its 2-year (supra-specialty) ICM training programme: The extensive documentation relating to this formal application has been collated and submitted to the Medical council (6March2015). It draws extensively on the established activities of the Faculty in overseeing training, defining standards, conducting an accreditation visitation programme and running its specialty Fellowship exam. Meanwhile the 'default' training programme continues and the advertising, selection and appointment process for July 2015 is in process. The new appointees for July 2015 include trainees from Anaesthesia and Medicine as base specialties.

Accreditation of the Faculty's trainers – the current consultants in ICM country-wide: The Faculty is arguing that its criteria whereby, essentially, FJFICMI holders who are currently in ICM practice in Ireland, would be facilitated in accessing the Specialist Register within the provisions of the Medical Practitioners Act (2007). The

Medical Council have not as yet accepted this approach but discussions are continuing.

2 Examinations and training: Under the chairmanship of Dr Andrew Westbrook, the Fellowship (written and viva) exam continues to develop and be run to an exceptionally high standard. It will remain as a summative assessment process taken in conjunction with the Faculty's competency based training. We thank the Faculty examiners who are central to running such a quality exam, particularly those who consistently contribute to the updating of the short answer and MCQ bank of the exam.


The committee has been to the fore in hosting the new European (EDIC) exam which is OSCE-based and addresses one of the aspirations of the ESICM – to achieve a consistent, reliable exam Europe-wide. In this process, Dublin has been one of six sites Europe-wide.

The regulations and 'pathways' of training (depending on the trainee's base-specialty background) have been revised and are updated for those taking on training from July

of this year. All such Faculty documents are available from the Faculty and will shortly be available on the Faculty's website.

The Accreditation Visitation process continues and, for the sake of logistic efficiency, is undertaken (where training ICUs are in question), in conjunction with the CAI Visitation process. Two JFICMI visitors are required for those visitations, where Special Interest Year (SIY) training is to be accredited and also at the four centres where Year 2 supra-specialty is being conducted. The implementation of competency based training together with its associated accreditation tools such as work-based assessments will be an increasing focus of such visitation processes.

3 Post-graduate Education The Faculty has continued its remit in organising the successful 3-day pre-Fellowship course. The 3-hospital format has been maintained and we thank Dr Andrew Westbrook and the individual hospital organisers (Dr Frances Colreavy and Dr Enda O'Connor) for providing a course with such value

and persistently positive feedback. The re-activated refresher course in ICM continues in a new novel format devised by Dr Enda O'Connor and it also receives very positive feedback. The series is targeted primarily at those taking exams and as a refresher for consultants and others working in Intensive Care. The Faculty will start its new Irish Donor Awareness Programme (IDAP) course this year and, given its importance to ICM practice and to medicine nationally, it will run as a required element of ICM training. We are indebted to Drs Colman O'Loughlin and Donal Ryan for their committed and pioneering work in this regard.

4 Paediatric Critical Care The National Standards document for Paediatric Critical Care Services in Ireland is operative and future documents (in collaboration with the Paediatric Critical care Group (PCCG), will delineate the entire pathway for critically ill children in need of Critical Care. The JFICMI continues to support the PCCG in its effort to secure parallel status with Adult Critical Care within the HSE Critical Care Programme (CCP). The CCP has given its approval and discussions continue. This process is reflective of the strong support of the JFICMI for the parallel evolution of Adult and Paediatric Intensive Care in Ireland - with strong Governance and Education / Training links.

Formal supervised training is

operative in Ireland with the introduction of an SI year and an advanced Fellowship year in PCCM. This welcome development will allow formal completion of specialist training in PCCM in the future and is analogous to corresponding developments in adult ICM.

The PCCG are working with the Examinations and Training Committee in evolving work based competency assessment and accreditation processes to ensure and sustain the quality standards of the JFICMI. Like Adult Critical Care, the PCCG envisages that a written exam will be a key component of accreditation in the future. The PCCG are engaging with the constituent Colleges to also explore how Paediatric Critical Care Medicine can be incorporated into the Specialist Registrar Programmes.

The continued support of the JFICMI, CAI, ICSI and CCP in the evolution of Paediatric Critical Care is greatly appreciated.

5 ICSI: Represented on our Board by its president, Dr Rory Dwyer, the implementation of last year's agreement between the two bodies on their relative roles in servicing Intensive Care nationally has been fruitful. This year's AGM of the JFICMI will be held again, by kind permission of the ICSI, in June 2015 at the time of its Joint Summer Scientific Meeting with the ESICM.

The JFICMI and ICSI cooperated in by instituting a joint response

group to newly proposed legislative change relating the Human Tissue and Assisted Decision Making Bills. We all thank Rory Dwyer for coordinating the visits to the departments of Justice and of Health and for the assistance of group members, Drs Brian Marsh and Barry Lyons.

In recognition of the increasing administrative activity of the two professional Critical Care bodies (ICSI and JFICMI), we have now agreed a formula to progressively subvent the funding of the equivalent of an administrative assistant for ICM at 22, Merrion Sq. and a new appointment is being made. A Memorandum of Agreement (MOA) is being agreed whereby this position can be optimally utilised and it is anticipated that this position will facilitate the pro-active development of ICM initiatives for both bodies.

6 College of Anaesthetists of Ireland (CAI): The JFICMI is currently housed at the CAI building as part of a generous arrangement to foster and financially support a 5-year set up phase for the JFICMI. This relationship has been extended pending the formal administrative acceptance of the ICM training programme with a related, anticipated level of HSE funding support. Practical on-going manifestations of the relationship are the representation on the Faculty Board by the CAI President, Dr Ellen O'Sullivan and by the invitation to our Dean to attend CAI council meetings and to the JFICMI Treasurer and Chair of examinations / training to attend corresponding CAI committees.

The CAI has been the most progressive in instituting positions within its postgraduate training scheme which allow formal training in Intensive Care Medicine thus allowing 2 month supervised, competency based, modules and 12-month Special Interest Year (SIY) training positions in ICM. The collaboration with the CAI Training committee

is particularly valued by the JFICMI and its recent acceptance of the results of a CAT committee survey which favoured earlier access to ICM training for Anaesthesia trainees is regarded as important, not just to the future of ICM in Ireland but also to the maintenance of a strong role of Anaesthesia-based doctors in ICM.

Another manifestation of the collaboration is the acceptance by the CAI Training committee of the JFICMI competency in Transport Medicine, thereby allowing joint acceptance and supervision by both bodies. A short course is also anticipated to help train and sign-off the competency.

7 Royal College of Physicians of Ireland:

While represented on the Board by Dr Ted Keelan, discussions have taken place with the Post Graduate Training Body (PGTB), the Irish Committee for Higher Medical Training (ICHMT) to facilitate the incorporation of Intensive Care Medicine into selected Specialist Registrar medical training programmes. This is possible as a 2-year supraspecialty (post base-specialty CST) now and the first year of training will also, in cooperation with the ICHMT, be possible as an 'out of programme year' akin to a 'SIY' year. Dr Enda O'Connor is the new agreed Liaison person for ICHMT trainees who are interested in ICM training. The JFICMI has affirmed its commitment to promoting training interactions with the ICHMT and with other specialties e.g. Emergency Medicine.

As part of these developments the ICHMT and the HSE education and planning office have expressed support for the development of 'Consultant physician with an interest in Intensive Care Medicine' positions as applies to Anaesthetists currently where one year of ICM Training plus success at the JFICMI Fellowship exam has been achieved.

8 Royal College of Surgeons in Ireland:

Linkage with the RCSI is maintained via the RCSI representative on the JFICMI Board, Mr Lars Nolke. It is anticipated that increased interaction with its Emergency Medicine Faculty will emerge as more Emergency Medicine trainees incorporate ICM training into their base specialty training and as some individual trainees may opt to pursue formal ICM training as mapped out in the Faculty's new Training Pathways and Regulations document.

9 National Critical Care Programme (NCCP)

is a constituent of the Clinical Strategy and Programmes Directorate (CSPD) of the HSE and is the Faculty's avenue of contact with HSE decision making – the mechanism for which is the nomination of Dr Michael Scully to the NCCP advisory body and the co-option of the NCCP Head, Dr Michael Power to our Board. Congratulations to Dr Michael Power on being re-appointed to this position, the ICSI and JFICMI having jointly taken part in the appointment process. The CCP continues to work on such areas as :

1. The evolution of the Critical care 'Hub-and-Spoke' Model within the new hospital groupings. The non-replacement of staff lost in the rationalisation of smaller ICUs is a current real issue for Critical Care nationally.
2. The implementation of the three Adult Critical Care Retrieval ser-

vices in Dublin, Cork and Galway under the clinical governance of the new National Retrieval Steering Committee. The MICAS committee is now subsumed into the new arrangement.

3. The initiation of the National Critical Care Audit Programme under the Chairmanship of Dr Rory Dwyer, the pilot site of which has now gone live. A steady broader roll-out is anticipated.
4. Managing Major ICU Surge activity e.g. Influenza A (H1N1) - Chair B Marsh. The activities of this group have been focussed on Ebola preparedness this year and protocols and procedures for the critical care management of such an instance have been expeditiously put in place by the committee.
5. Post graduate Critical Care Nurse education: Preliminary discussions have started (facilitated by the CCP) regarding the issue of promoting Quality and more standardised post graduate nurse education nationally.
6. ICU Bed Information System (ICUBIS - 'Bed Bureau') in development with HSE ICT.
7. Infection Surveillance – Audit Programme may facilitate on-going surveillance.

10 Board composition and elections:

The elections to the Board of the Joint Faculty for 2015 will take place shortly when two positions will be vacant / available for re-election. The Board

has six elected members and four members representing the parent bodies. There may however be a need at the next AGM to consider whether the number of elected members requires some limited expansion. We were pleased to institute a new elected trainee post last year, Dr Ruth Aoibheann O'Leary; Dr Aisling McMahon (representing Anaesthesia trainees) have been very effective in advancing new innovations, particularly the very successful recent survey of Anaesthesia trainees with reference to ICM training. As Dean, I can readily state that the Board has worked very effectively with many members making major contributions both individually and via their committee or sub-group work.

11 Specialty status administrative responsibilities.

The increase in this activity is being effected on behalf of the training bodies – the CAI, RCPI and RCSI. The 5-year financial projection of Dr Maria Donnelly (Hon Treasurer) is being followed and new developments have been the definition (in monetary terms) of the value of the CAI support to the Faculty and the institution of a funding basis for the JFICMI and ICSI administrative support for Critical Care at the office – see ICSI above. Meetings are anticipated with all training bodies to discuss the implementation of ICM training on their behalf and the associated financial requirement and arrangements.

12 Website: This has been a top priority for the JFICMI and Dr Enda O'Connor has very ably led the implementation subgroup. Collaboration with the web provider company, Strata 3, is working well and 'going live' is planned for April 2015. This will be an undoubted major step forward for the Faculty which will hugely improve its capacity to provide a service for Trainees and Fellows and to such activities as Education, Examina-

tions, Visitation programme and in time PCS facilitation for Specialists in practice.

13 Conclusion: The JFICMI will continue its role in promoting and accrediting quality ICM training. We will be pleased, as part of our responsibility to ICM in Ireland to interact with Consultants and Fellows nationally to facilitate their attainment of specialty status in ICM and thereby consolidate their roles as valued trainers for the Faculty. In time, we anticipate offering the facility for PCS compliance in ICM. We remain concerned at the current 'default' nature of our Training programme and have, as a top priority, the accreditation of the programme with the IMC and regularisation of the status of the trainees and trainers. We remain indebted to the support of the various colleges, particularly the CAI, in this evolution.

FACULTY OF PAIN MEDICINE ANNUAL REPORT

The board met on three occasions – 30th January, 26th May and 05th December 2014.

The Annual Scientific Meeting took place between January 30th – February 1st on the theme of “Chronic Pain – Strikes All Ages” – overall attendance 257. International speakers included – Dr Michael Stanton-Hicks (Cleveland Clinic USA), Mr Bill Rittman (Boston USA), Professor Peter Passmore (Queen’s University Belfast), Professor Patricia Schofield (University of Greenwich UK), Dr Kevin McCarthy (Great Ormond Street Hospital for Children London), Dr Gareth Jones (Aberdeen UK), Dr Sam Eldabe (Middlesbrough UK), Dr Arun Bhaskar (Manchester UK) and Dr Simon Thompson (President Neuromodulation Society, UK). The ASM included a very successful day in the College (126 in attendance) with an R&D session, a nurse symposium and a GP/Multidisciplinary Refresher Course on the Friday with the main congress taking place in the Convention Centre on the Saturday (149 attendees). On Thursday evening in the College Dr Michael Stanton-Hicks gave the inaugural Dr Francis Rynd Lecture “Pain Medicine – A perspective from the Cleveland Clinic and a career spanning three continents” (39 in attendance) followed by the conferring ceremony of the Faculty of Pain Medicine CAI. The meeting was very well received with positive feedback.

The Winter Meeting on December 5th was held in the CAI. Dr Connail McCrory spoke on ‘Neuropeptides’ and Chronic Pain’ and Dr Josh Keaveny spoke on ‘Intrathecal Baclofen Therapy’.

Pain Medicine was awarded Specialty status by the Medical Council. Ireland is the first European country to achieve this and other countries are using the FPMCAI as a model in their applications for similar status. This confers Pain Medicine equal status with other specialties for undergraduate and postgraduate training and education. Programs will be developed to reflect this and will enhance the specialty for patient care and career development.

Fellowship and Diploma examinations were held in June 2014. This was preceded by a Revision Course in Pain Medicine. The attendance reflected the continued and growing interest in Pain Medicine as a specialty.

Pain Medicine was awarded Specialty status by the Medical Council. Ireland is the first European country to achieve this and other countries are using the FPMCAI as a model in their applications for similar status.

The College of Anaesthetists of Ireland signed an agreement with the Irish Medical Council in 2011 under The Medical Practitioners Act 2007 to administer a Professional Competence Scheme (PCS) on behalf of the Medical Council for registered doctors aligned to Anaesthesia, Critical Care & Pain Medicine.

Since 1st May 2011 all registered medical practitioners are required to enrol in and maintain their Professional Competence. Over the past three years, a significant investment has been required by all PGTB's to implement and maintain these schemes from online software upgrades, manpower and administration and the submission of annual reports to the Medical Council.

The PCS year runs from 1st May to 30th April each year. Once a registrant is enrolled in the scheme they have access to record PCS activity through an online diary available on the College website. A Statement of Participation is issued at the end of the PCS year stating all activity that has been recorded. When renewing registration with the Medical Council, a doctor is asked to declare in good faith that he/she is enrolled in a Professional Competence Scheme. The current number of registrants for CAI is 772.

The annual fee covers the cost of investment by the College in software, administration and database management. In order to be fully registered for PCS the annual fee must be paid. The PCS fee for 2014-2015 is €220 for registrants in good standing and €350 for registrants not in good standing and a further 5% discount if payment is received by the end of August.

Under the terms of the agreement with the Irish Medical Council, CAI is obliged to undertake an annual verification of a sample of Statements of Participation. 3% of all registrants (20 selected in 2014) are randomly selected and are asked to provide documentation to support the data that has been uploaded to the PCS diary. In addition to the verification process carried out by CAI, the Irish Medical Council will undertake an annual audit of a random sample of registered doctors. If you are selected for this audit you will be asked to submit a copy of your PCS Statement of Participation. In 2014 the Irish Medical Council also asked all Training Bodies for details of doctors who have registered for PCS but failed to record any PCS points.

We are reaching the end of the fourth year of PCS. CAI has endeavoured to keep the PCS process as simple and user friendly as possible for both meeting organisers and PCS registrants. PCS Frequently Asked Questions are available on our website.

HONORARY TREASURER'S REPORT




This is my second report to the fellows of the College of Anaesthetists of Ireland in my role as Honorary Treasurer and Chairman of the Finance committee. During the Financial Year 2014 the Finance committee met on seven occasions. We held our Finance Audit meeting in Galway this year during the Western Anaesthesia Meeting in March. I am pleased to report that in the last twelve months your College has consolidated its strong financial position due to the ongoing support of you the valued fellows of the College. The accounts were audited by

Grant Thornton. We have received a clean audit opinion, which means that the financial statements were presented fairly in all material aspects, and no concerns, nor comments, were expressed. The Financial Statements of the College for the year ended 31st December 2014 are set out on pages 41 to 43 of this annual report.

Income & Expenditure Account

The total income of the College for the financial year ended 31st December 2014 was €3,670,485 this is an increase of 15% when compared to 2013. While HSE



funding remains our largest source of income we have reduced our reliance from 54% in 2013 to 45% in 2014. The expenditure for the year was €2,605,124 this is an increase of 2% when compared to 2013. Our surplus for the year was €1,065,361 this is an increase of 56% when compared to 2013. The balance sheet for 2014 details the Colleges assets and liabilities, and I am delighted to say that the net assets now total €2,371,102; The net assets increased by 24%. The College cleared the mortgage in December 2014. The increase in our surplus this year is mainly account-

ed for by income from the MV Ireland project and a deduction in depreciation due to the revaluation last year of our building in Merrion square. While we hope to continue to develop new income streams such as MV Ireland it is early days yet in this strategic plan. We are very attentive to ensuring our activities are costed appropriately and stay within budget.

We have established a finance strategy group to consider medium to long term college finance plans and I hope to outline the results of this process next year. The Strategy group has already deployed one

major decision by committing 70K for an inaugural research fund. It will be an iterative process and is based on the NIAA in the UK. It is aimed at CST graduates in an effort to assist start up investigators and improve graduate retention within the health service. The award for the successful project will be announced at our Annual Congress meeting in May 2015. During 2015 members will be invited to submit projects and initiatives to our academic committee for




